

Message From The Exalted Ruler



In the December newsletter I mentioned that I would share more details concerning the recent activity of our Lodge supporting worthy community involvement initiatives. The Board decided earlier this year not to let the Covid pandemic prevent us from supporting this community. We secured several Elks National Foundation grants for this purpose and only this grant money has been used for these worthy programs.

On November 5, of this past year, several members delivered 35 gas/oil cards to the *Muskegon County Department of Veteran Affairs* (MCDVA). We were able to meet with the Director Mike Baauw and deliver these debit cards in person. Valued at \$40

each, the cards were to be used by *Peace Era Veterans* (PEV's) for travel to doctor appointments, work and back-to-work programs. While visiting with Mike, two Army PEV's came to the office and we were able to personally give them each a card. They

were very appreciative and shared their stories of the difficulties they were facing. We were pleased that our Lodge could be of assistance.

In early December we began purchasing items for Welcome Home Kits to support PEV's returning to a home or who had secured temporary housing. The items were delivered to MCDVA on December 11 by four Elks volunteers. The kits were assembled on December 15 by six more volunteers. It was amazing to see the looks on the faces of the PEV's as they saw not only the cleaning materials, linens, and towels, but also the small appliances such as toasters and coffee makers. Knowing that the Elks are assisting those who have served this country is truly heartwarming.

On December 15 we purchased two computers loaded with game software for children in residence at *Family Promise of the Lakeshore*. The software is learning software aimed at improving thinking, reading and mathematical skills for children ages five through sixteen. These children are part of homeless families who are undergoing skills training so that the parents can re-enter the job market and effectively manage their homes and finances. The children will benefit from their time on the computers as the learning software will improve their literacy and help them stay up with their peers who do not have to deal with issues of relocation and learning disruption. It is a little-known fact that every time a child of a homeless family relocates, they lose three months of education and learning. The Elks hope that this initiative will, in some small way, help close the learning gap for these children.

On an unrelated topic, I would like to close this message with a reminder to all members that on Monday, January 18, during our regular Lodge meeting, we will be holding nominations for the officer positions in our Lodge. Nominations will be held for the four chair officers, Secretary, Treasurer, Tiler and one Trustee position. Give serious consideration to serving our Lodge as an officer. If you have an interest in serving the Lodge as an officer or have any questions about the responsibilities of these positions, feel free to contact me personally or any other current officer. I particularly urge our new members to consider nomination for one of these positions. New ideas and energy are always welcome from new officers!

Elk Scholarships

Legacy Award: Legacy Awards are \$4,000 scholarships (\$1,000 per year for four years). The Elks Foundation will offer a total of up to 250 awards. Applications must be submitted by *February 5, 2021*.

Who is Eligible?

1. Any child or grandchild (or step-child, step-grandchild, or legal ward) of a living Elk who joined the order on or before April 1, 2018, or a charter member of a Lodge that was instituted on or after April 1, 2018, is eligible to apply. The Elk must also be a paid-up member through March 31, 2021. Great-grandchildren are not eligible.

2. The applicant must be a high school senior.

The applicant must <u>apply online only</u>. (Elks.org/enf/scholars/)

1. If the applicant's parent and grandparent are both Elk members, the applicant must apply through the parent's Elks Lodge.

2. Students **may apply** for more than one ENF scholarship; however, they may win only one. In cases where the student qualifies for more than one, we will award the scholarship with the greater value.

3. Legacy Awards may only be applied to accredited US American schools, colleges or universities. (Note: Applicants from Guam, Panama, Puerto Rico and the Philippines may apply Legacy Awards toward schools, colleges or universities in their respective homes.)

Applicants must take the Scholastic Aptitude Test or the American College Test by December 31, 2020.

MUSKEGON COUNTY VETERANS RECEIVE LODGE ASSISTANCE

Several Elk volunteers, and their willing spouses, made possible the purchase, delivery, and assembly of ten "Welcome Home Kits" for Muskegon County Peace Era Veterans (PEV's) a reality.

Various items were ordered that are needed in any home when first moving in: pans, blenders, coffee makers, silverware, dishes, linens, towels, and cleaning supplies. A caravan was organized to carry these items to the Muskegon County Department of Veterans' Affairs (MCDVA). Four days later another group of Elk volunteers, assembled all these items into ten welcome home kits.

MCDVA director, Mike Baauw, thanked our Lodge for the contributions and plans were made to begin the distribution to qualified PEV's during Christmas week.

Money received from the Grand Lodge ENF Spotlight Grant made this initiative possible. The welcome home kits could not have been sent to a more appreciative group than the PEV's of our county.

Michigan Elks Major Projects:

1. Assist Special Needs Children to become selfsufficient, healthy, contributing citizens.

2. Provide funds for children to attend more than fifteen different therapy camps in Michigan.

3. Provide Emergency Fund Grants for children hurt in accidents, fire, in need of organ transplant, etc.

4. Provide help annually for hundreds of children with medical and therapy equipment. The Major Project annual budget exceeds \$260,000 to help meet those needs.

Michigan Gold Key:

1. Provides scholarships for Special-Needs Students* who want to pursue higher education at an accredited educational institution or a licensed vocational school. 2. Helps students become self-respecting, self-reliant, self-supporting, contributing members of society. Gold Key is currently providing \$2,000 annual scholarships to nineteen Special Needs Students. These are renewable for up to four years for a total of \$8,000 for each student. *Special Needs Students are those who are physically or otherwise challenged.

Peace Era Veterans Get Gassed Up

Money received from the Grand Lodge Elks National Foundation Beacon Grant made possible the purchase of thirty-five \$40 gas/oil debit cards for use by Peace Era Veterans (PEV's) of Muskegon County.

The cards were purchased in early November and delivered to Mike Baauw, director of the Muskegon County Department of Veterans Affairs (MCDVA) on November 5.

While on site two Army PEV's arrived and we were able to personally distribute the first two cards to them. They both told their story of tight funds and the inability to get to doctor appointments and work without this assistance. They were genuinely grateful. Since then, others have also received this assistance and our Lodge has had the pleasure of a personal phone call from one veteran who personally thanked our Lodge for supporting him.
